# Electric Interim Rate Increase 

Effective March 1, 2024

Montana-Dakota Utilities Co. (Montana-Dakota) is implementing an interim rate increase as part of the Company's pending 2023 electric rate increase application. As previously noticed in your September 2023 bill, Montana-Dakota filed an electric rate increase request with the South Dakota Public Utilities Commission (Commission) on August 15, 2023. If approved by the Commission as filed, the proposed new rates will result in an overall increase of $\$ 3.0$ million or 17.3 percent over current rates. The Company has made significant investments in its electric infrastructure to ensure safe and reliable service to customers, as well as investments in technology to provide better service since the Company's last rate case in 2015 causing the need for an increase in rates.

On September 1, 2023 the Commission ordered the proposed rates be suspended for 180 days, pursuant to South Dakota law, as the Commission considered the Company's case. The 180 day suspension period expired on February 11, 2024.

On January 26, 2024, Montana-Dakota filed a Notice of Intent to Implement Interim Electric Service Rates with the Commission, reflecting an interim revenue increase of $\$ 2.7$ million. Interim rates will be implemented effective with service rendered on and after March 1, 2024. If the final approved increase is lower than the interim increase, Montana-Dakota will refund the difference
to customers with interest. The Company's Infrastructure Rider, Transmission Cost Recovery Rider, and Fuel and Purchased Power Adjustment will change effective March 1, 2024. The March 1, 2024 changes are summarized in the table below.

*The interim increase will be applied as a percent of your electric service bill (excluding the Fuel and Purchased Power and the Transmission Cost Recovery and Infrastructure Riders) and will be shown as a separate line item on your bill. The first bill you receive may be prorated, depending on the date your meter is read. This means that only the portion of your bill for service on and after March 1, 2024 will reflect the interim rate increase.
