How to Figure your bill:

The information is to assist you in calculating your bill. A residential rate is used for this example.

1. Assume a month's use of 4 dk
 2. Basic Service Charge ($\$0.26 \times 31$ days) \$8.06
 3. Distribution Delivery Charge ($\$1.034 \times 4$ dk) \$4.14
 4. Cost of Gas (as of October 1, 2019) ($\$3.602 \times 4$ dk)... \$14.41
 5. Gas Tax Tracking Adjustment ($.261244 \times \$12.20$)..... \$3.19
- Total Bill** **\$29.80**



TIME FOR ANNUAL NATURAL GAS RATE REVIEW IN MONTANA

The purpose of this brochure is to provide you with information regarding your natural gas rates. The Company's tariffs are not changing; however, this information may be helpful when reviewing your natural gas bill.

Natural gas usage is measured in decatherms. The abbreviation dk is used in the rate schedules. The prices for various classes of customers are shown below.

The Cost of Gas (COG), approved by the Montana Public Service Commission, is subject to change monthly either upward or downward depending on the specific circumstances of the period it covers including purchased gas costs and other costs that are passed along to us by our pipeline suppliers. The COG is strictly a pass-through to our customers and does not provide Montana-Dakota with a profit.

The Gas Tax Tracking Adjustment is applicable to the amounts billed under the Basic Service Charge and Distribution Delivery Charges of all gas rate schedules. The adjustment reflects changes in Montana-Dakota's Montana state and local taxes and fees as compared to the base levels approved in its most recent general rate case.
