

## Notice of North Dakota Public Input Sessions

The North Dakota Public Service Commission (Commission) has scheduled two informal public input sessions to be held remotely on Tuesday March 2, 2021 at 12:00 p.m. central time and 5:30 p.m. central time to allow customers of Montana-Dakota Utilities Co. (Montana-Dakota) and Great Plains Natural Gas Co. (Great Plains) the opportunity to present their input regarding Montana-Dakota's application to increase their natural gas distribution rates filed with the Commission on August 26, 2020. Due to the state of emergency, the public input sessions will be held remotely.

Montana-Dakota's request is for an overall increase of 7.8 percent over current rates or approximately \$8.97 million in additional annual revenues if approved by the Commission. The increase is primarily due to increased investment in the Company's natural gas facilities to improve system safety and reliability. A Montana-Dakota residential customer would see an average increase of \$6.26 per month annually if approved.

As part of this regulatory filing, Montana-Dakota is also seeking to combine natural gas operations within North Dakota, which

means transitioning the 2,355 Great Plains customers in Wahpeton and surrounding areas to Montana-Dakota. Upon implementation of final rates in this case, Great Plains' Wahpeton customers will be served under Montana-Dakota's tariffs, and after a one-year transition period, will begin receiving their natural gas bills under a Montana-Dakota invoice.
