

# Heating Assistance

## is available to make ends easier to meet.

(LIHEAP) This program is funded by the Federal Government and is administered through the Department of Public Health and Human Services. The awards are based on your previous 3 months' gross income, type of fuel used, number of people in the household, and the size, type & location of your home. If your household receives benefits from Supplemental Security Income (SSI), Supplemental Nutrition Assistance Program (SNAP), or the Temporary Assistance to Needy Families (TANF) program, you may qualify automatically for weatherization or fuel assistance.

Montana-Dakota Utilities Co. encourages you to complete your application today for the federal energy assistance program so you can start receiving your benefits this heating season to cover fuel costs incurred from October 1, 2021 through April 30, 2022.

The Montana LIHEAP program has received additional funding through the American Rescue Plan Act (ARPA) for the 2021-2022 heating season and is able to assist Montana-Dakota customers who may owe past-due amounts on their utility bills.

#### Low Income Discount

Montana-Dakota customers who are approved for the federal energy assistance program can also receive up to a 30% discount on their Montana-Dakota bill.

#### Furnace or Water Heater Repair/Replacement

Montana-Dakota customers may also be eligible for assistance in repairing or replacing an unsafe furnace or water heater. Please contact District VII HRDC at 800-433-1411 or Action for Eastern Montana at 800-227-0703 to apply.

Energy Share is a private nonprofit organization with the goal of helping Montanans faced with energy emergencies meet their needs.
