

Montana-Dakota Utilities Co.
Annual Update to the Generation
Resource Recovery Rider
Effective February 1, 2022

On November 1, 2021 Montana-Dakota Utilities Co. (Montana-Dakota) filed an application with the North Dakota Public Service Commission (Commission) to update its Generation Resource Recovery Rider (Generation Rider). The Generation Rider update includes North Dakota's allocation of the Company's investment in its Reciprocating Internal Combustion Engines (RICE) units at its Lewis & Clark Generation Station that are currently not being recovered through the Company's electric service rates.

On January 18, 2022, the Commission approved Montana-Dakota's Generation Rider rates effective with service rendered on and after February 1, 2022. A typical residential customer using 894 Kwh will see a decrease of \$0.03 per month or a decrease of \$0.36 annually. The Generation Rider is shown as a separate line item on your bill.

Resource Cost Adjustment
Effective February 1, 2022

On November 1, 2021, Montana-Dakota Utilities Co. (Montana-Dakota) filed an application with the North Dakota Public Service Commission (Commission) to update its Renewable Resource Cost Adjustment (RRCA). The RRCA rate update includes North Dakota's allocation of the Company's investments in Montana-Dakota's three wind facilities (Diamond Willow, Cedar Hills, and Thunder Spirit) that are currently not being recovered through the Company's electric service rates.

On January 26, 2022, the Commission approved Montana-Dakota's RRCA rates effective with service rendered on and after February 1, 2022. A typical residential customer using 894 Kwh will see a decrease of \$1.20 per month or a decrease of \$14.40 annually. The RRCA is shown as a separate line item on your bill.
