Electric Service Rates Effective July 15, 2022

On May 16, 2022, Montana-Dakota Utilities Co. (Montana-Dakota) filed an application with the North Dakota Public Service Commission (Commission) for an increase in rates charged to its customers for electric service. If approved by the Commission, the proposed new rates will result in an increase in total revenue of approximately \$25.4 million or 12.3 percent. The primary reason for the increase is increased investments necessary for providing safe and reliable electric service to the Company's customers.

State law allows Montana-Dakota to charge an interim rate while the Commission considers the Company's request. On July 14, 2022, the Commission approved an interim rate increase in the amount of \$10,922,625 or an overall increase of 5.3 percent. The Commission is allowed seven months, from the date of the Company's filing, to issue a final decision. If the final approved increase is lower than the interim increase, Montana-Dakota

will refund the difference to its customers with interest. A typical non-space heating residential customer using 800 Kwh a month will see, on average, an increase of \$5.09 a month.

The interim rate of 8.909% is effective with service rendered on and after July 15, 2022. The interim rate will be applied to the Basic Service Charge, Energy Charge, and Demand Charge applicable under each rate schedule and will be shown as a separate line item on your bill. The first bill you receive may be prorated, depending on the date your meter is read. This means that only the portion of your bill for service on and after July 15, 2022 will reflect the interim rate increase.
