preceding 12-month period will be charged the Basic Service Charge applicable during the period service was not being used and a \$30.00 reconnection fee during normal business hours. However, the reconnection application to seasonal businesses, such as swimming facilities and asphalt processing, may receive credit for the Distribution Delivery Charge revenue collected while in service.

How to Figure your bill:

The information is to assist you in calculating your bill. A residential rate is used for this example.

- 1. Assume a month's use of 2 dk
- 2. Basic Service Charge (\$0.8244 x 30 days) \$24.73
- 3. Cost of Gas (as of Sept. 1, 2022) (\$10.293 x 2 dk) \$20.59

 Total Bill (not including tax)......\$45.32

The Cost of Gas is strictly a pass-through to the Company's customers and does not provide Montana-Dakota with a profit.

Payment:

Bills will be considered past due if not paid by the due date shown on the bill. An amount equal to 1% per month will be applied to any unpaid balance existing at the immediate subsequent billing date.

NSF Returned Check Charge:

A charge of \$15.00 will be collected by the Company for each check charged back to the Company by the customer's financial institution.

Seasonal Reconnection Charges:

A residential customer who requests the reconnection of service at the same location the customer discontinued the same service during the preceding 12-month period will be charged the Basic Service Charge applicable during the period service was not being used and a \$30.00 reconnection fee during normal business hours. Standard overtime rates will be applied for reconnecting service after normal business hours.
