

**Transmission Cost Adjustment (TCA)**

A charge per Kwh applicable to electric service for the recovery of transmission related expenditures and investments net of revenues received from others. The TCA is subject to change on an annual basis.

**Renewable Resource Cost Adjustment (RRCA)**

A charge per Kwh applicable to electric service for the recovery of jurisdictional costs associated with renewable generation resource modification or additions approved by the Commission but not recovered through retail rates. The RRCA is subject to change on an annual basis.

**Generation Resource Recovery Rider (GRRR)**

A charge per Kwh/Kw applicable to electric service for the recovery of jurisdictional costs associated with generation resources approved by the Commission but not recovered through retail rates. The GRRR is subject to change on an annual basis.

**Seasonal Reconnection Charges:**

A charge of \$20.00 for customers with non-demand meters and \$40.00 for customers with demand meters will be collected for reconnecting electric service to a customer who requests reconnection of service at a location where the same customer discontinued the same service during the preceding twelve-month period.

**Payment**

Bills will be considered past due if not paid by the due date shown on the bill. An amount equal to 1% per month will be applied to any unpaid balance existing at the immediate subsequent billing date.

**NSF/Returned Check Charge**

A charge of \$15.00 will be collected by the Company for each check charged back to the Company by the customer's financial institution.

The purpose of this brochure is to provide you with information regarding your electric energy rates. The Company's tariffs are not changing; however, this information may be helpful when reviewing your electric bill.

# Review of Energy Costs for Montana-Dakota Electric Customers as of August 1, 2025

Electric energy is measured in Kilowatt-hours. The abbreviation Kwh is used in the rate schedules below.

Electric demand is measured in kilowatts. The abbreviation Kw is used in the rate schedules below.

## Residential Electric Service—Rate 10

This rate applies to all communities served for single-phase residential electric service for domestic purposes only.

The fuel and purchased power adjustment is subject to change on a monthly basis and includes the cost of fuel burned in generating plants to produce electricity and purchased capacity and energy costs.
