2025 will be billed at the old rate and any natural gas used on and after August 1, 2025 will be billed at the new rates.

Payment:

Bills will be considered past due if not paid by the due date shown on the bill. An amount equal to 1% per month will be applied to any unpaid balance existing at the immediate subsequent billing date.

Returned Check Charge:

A charge of \$30.00 will be collected by the Company for each check charged back to the Company by the customer's financial institution.

Seasonal Reconnect Charge:

A Residential Rate 60 customer who requests the reconnection of service at the same address within a 12-month period will be charged the Basic Service Charge applicable during the period service was not in use and a \$30.00 reconnection fee during normal business hours. Standard overtime rates will be applied for reconnecting service after normal business hours.

A non-residential customer who requests the reconnection of service at the same address within a 12-month period will be charged the Basic Service Charge applicable during the period service was not in use and a \$30.00 reconnection fee during normal business hours. The reconnection charge applicable to seasonal business concerns such as irrigation, swimming facilities and asphalt processing, shall be the Basic Service Charge applicable during the period service was not being used less the Distribution Delivery Charge revenue collected during the period in-service above the annual authorized use by rate class. Standard overtime rates will be applied for reconnecting service after normal business hours.

On October 31, 2024, Montana-Dakota Utilities
Co. (Montana-Dakota) filed an application with the
Wyoming Public Service Commission (Commission)
for an increase in the Company's natural gas
rates of \$2.6 million annually or 14.3 percent over
current rates. The primary reasons for the increase
are investments in system upgrades and pipeline
replacement projects that will enhance the reliability,
safety and integrity of the natural gas system, as
well as increased costs to operate and maintain that
system. Montana-Dakota's last increase in its natural
gas distribution rates was in March 2020.

On May 9, 2025, Montana-Dakota and the Wyoming Office of Consumer Advocate (OCA) jointly filed a Stipulation and Agreement (Stipulation) with the Commission, resolving all outstanding issues between the Company and the OCA including the amount of the increase and the allocation of the increase amongst the customer classes. On June 24, 2025, the Commission held a Public Hearing on the Company's request and the Stipulation. At the Public Hearing, the Commission authorized an annual increase in revenues of approximately \$2.1 million annually or 11.68 percent effective August 1, 2025. The overall increase by rate class is 15.46% for residential service, 5.83% for firm general service and 0.10% for large interruptible service

The actual impact to customers' bills will vary depending on the customer's rate class and the amount of natural gas used. A typical residential customer using 89 dk on an annual basis will see an average increase of \$8.12 per month associated with the change in distribution rates.

The rates for the various classes of service are shown below. The Cost of Gas is strictly a pass-through cost to customers and is subject to change on a monthly basis as outlined in the Company's tariff.
