

Basic Service charge applicable during the period service was not being used and a \$30.00 reconnection fee if reconnection occurs during normal business hours. However, the reconnection fee applicable to seasonal businesses, such as swimming facilities and asphalt processing, may receive credit for the Distribution Delivery Charge revenue collected while a customer was in service.

**How to figure your bill:**

This information is to assist you in calculating your bill. A residential rate is used for this example.

- 1. Assume a month's use of 2.5 dk
- 2. Basic Service Charge (\$0.32 x 31 days) ..... \$9.92
- 3. Distribution Delivery Charge (\$2.532 x 2.5 dk) ..... \$6.33
- 4. Conservation Tracking Adjustment (\$0.016 x 2.5 dk) .. \$0.04
- 5. Cost of Gas (as of October 1, 2025) (\$5.286 x 2.5 dk).. \$13.22
- Total Bill (not including tax)..... \$29.51**

The purpose of this brochure is to provide you with information regarding your natural gas rates. The Company's tariffs are not changing; however, this information may be helpful when reviewing your natural gas bill.

Natural gas usage is measured in decatherms. The abbreviation dk is used in the rate schedules which follow. The prices for various classes of customers are shown below.

**Cost of Gas (Purchased Gas Cost Adjustment)  
Rate 88**

The Cost of Gas is subject to change monthly either upward or downward depending on the

specific circumstances of the period it covers including purchased gas costs and other costs that are passed along to the Company by pipeline suppliers. The Cost of Gas is strictly a pass-through to the Company's customers and does not provide Montana-Dakota with a profit.

**CTA (Conservation Tracking Adjustment) Rate 90**

A charge per Dk, applicable to customers billed under Residential Service Rate 60 and Firm General Services Rates 70 and 72, for the recovery of costs related to a portfolio of conservation programs as authorized by the South Dakota Public Utilities Commission. The charge is subject to change on an annual basis.

**Payment:** Bills will be considered past due if not paid by the due date shown on the bill. An amount equal to 1% per month will be applied to any unpaid balance existing at the immediate subsequent billing date.

**Returned Check Charge:** A charge of \$40.00 will be collected by the Company for each check charged back to the Company by the customer's financial institution.

**Seasonal Reconnection Charges:** A residential customer who requests the reconnection of service at the same location the customer discontinued the same service during the preceding 12-month period will be charged the Basic Service charge applicable during the period service was not being used and a \$30.00 reconnection fee if reconnection occurs during normal business hours. Standard overtime rates will be applied for reconnecting service after normal business hours.

A non-residential customer who requests the reconnection of service at the same location the customer discontinued the same service during the preceding 12-month period will be charged the
