



Notice of North Dakota Public Input Sessions

The North Dakota Public Service Commission (Commission) has scheduled informal public input sessions via interactive television on Tuesday, October 24th at 5:00 p.m. CDT and Wednesday, October 25th at 5:00 p.m. CDT to allow customers of Montana Dakota Utilities Co. (Montana-Dakota) the opportunity to present their input regarding Montana-Dakota's application to increase their natural gas distribution rates filed with the Commission on July 21, 2017.

Montana-Dakota's request is for an overall increase of 5.4 percent over current rates or approximately \$5.9 million in additional annual revenues if approved by the Commission. The increase is primarily due to increased investment in the Company's natural gas facilities to improve system safety and reliability and the depreciation and taxes associated with the increased investment. A residential customer would see an average increase of \$2.98 per month or 5.9 percent annually. The proposed increase for residential customers would raise the Basic Service Charge from \$19.60 to \$22.58 a month.
