## **PROGRAM TERMS & CONDITIONS:**

### **QUALIFICATIONS**

- The qualifying equipment must be installed in a Montana residence served with electricity from Montana-Dakota Utilities Co. (Montana-Dakota).
- The residence must be served under Montana-Dakota's Residential service rates 10, 11 or 16.
- The Residential LED Rebate is limited to a maximum of 40 bulbs per residential customer account.
- Rebates issued for 50% of purchase price (not to exceed \$5/bulb for A-line, 40W, 60W, 75W, or 100W equivalent; or not to exceed \$7/bulb for Globe, Indoor Flood or Outdoor Flood) – rebate amount will be calculated based on the retail sales price and will not include applicable sales tax.

### **APPLICATION REQUIREMENTS**

- Rebate applications must be submitted within 90 days of the purchase date.
- The rebate application must be completely filled out with the purchaser information, equipment information (including brand and model).
- A copy of the receipt(s) indicating the date of purchase, manufacturer brand and model number of equipment must accompany this rebate application.
- Montana-Dakota is unable to accept applications that do not include all required information.
- It is the responsibility of the purchaser to ensure that the installed equipment qualifies for the rebate. If the equipment does not qualify, no rebate will be paid.

### **REBATE PAYMENT DETAILS**

Montana-Dakota issues rebates in the form of a check, not a utility bill credit. Allow 4-6 weeks for rebate processing.

Rebate qualifications and amounts are subject to change and funding for the program is limited. Completed rebate applications will be processed in the order in which they are received. Rebates will not be paid if funds are depleted prior to the end of the plan year (January 1 - December 31).

**Montana-Dakota reserves the right to cancel or modify these programs at any time.**
