## **Trade Ally Benefits**

- 1. All Trade Allies will be listed on the Montana-Dakota website as a Trade Ally, so customers know a Trade Ally is a contractor who can assist them with service and installation and qualifying and obtaining when applicable Montana-Dakota's conservation incentives, federal or state tax credits and other benefits offered to participants through the Montana-Dakota Trade Ally program.
- 2. Trade Allies will be eligible to receive customer leads or referrals and/or project requests for the products and services indicated on their Montana-Dakota Trade Ally application.
- 3. Trade Allies will be eligible to participate in exclusive marketing and training programs that may be offered by Montana-Dakota.
- 4. Trade Allies are authorized to use the Montana-Dakota Trade Ally logo consistent with the following Montana-Dakota usage guidelines:



- a. Trade Ally must submit all proposed materials using the Montana-Dakota Trade Ally logo for review and approval by Montana-Dakota. Trade Ally shall discontinue all use of Montana-Dakota's Trade Ally logo upon written notice from Montana-Dakota or upon Trade Ally discontinuance as a participant in Montana-Dakota's Trade Ally program.
- b. Trade Ally may use the logo in connection with and solely for the purpose of promoting product and services they offer and list on Montana-Dakota's Trade Ally application.
- c. Trade Ally may use the Trade Ally logo only on materials that involve products or service related to the energy supplied by Montana-Dakota in the market served by the Trade Ally.
- d. The logo must be sized so all text in the logo is readable.
- e. No aspect of Montana-Dakota's Trade Ally logo may be changed by the Trade Ally.
- f. The Montana-Dakota Trade Ally logo may not be used in conjunction with any other utility or any company other than the Trade Ally without authorization from Montana-Dakota.

## **Trade Ally Requirements**

- Trade Ally is responsible for properly assisting customer with the offered services as indicated on their Montana-Dakota Utilities Co. (Montana-Dakota) Trade Ally application.
- Trade Ally must use accepted HVAC industry standard design and sizing calculations to ensure HVAC systems operate at maximum efficiency and comfort.
- 3. Where applicable, Trade Ally is responsible for properly assisting customers in applying for cash incentives for purchasing and installing energy efficiency equipment under Montana-Dakota's conservation incentive programs.
- 4. Trade Ally will indemnify, defend and hold harmless Montana-Dakota and their affiliates as well as the directors, officers and employees of each, from any claims of any kind, including attorney fees, arising out of or connected in any way with any act or omission of the Trade Ally, its employees, agents or subcontractors of any tier, in the performance or nonperformance of services as part of the Trade Ally program.
- Trade Allies must supply a valid contractor's license, comply with laws applicable to them (such as workers compensation and employment laws) and maintain appropriate licenses and certifications for the work they are performing.
  - a. State required workers compensation insurance must be maintained as well as acceptable occurrence based general liability, not less than \$1,000,000 and commercial automobile liability insurance not less than \$500,000.
  - b. Trade Ally will provide evidence of insurance to Montana-Dakota in the form of a certificate for the required coverage. Trade Ally insurance certificate shall include "Montana-Dakota Utilities Co." as additional insured. The Trade Ally will notify Montana-Dakota if it no longer has the license certification or insurance required to be a Trade Ally in the program. Self-insured contractors must provide documentation of their insurance program that confirms their insurance is comparable to the \$1,000,000 and \$500,000 requirements. This document is subject to review prior to Trade Ally enrollment and acceptance.
- 6. Trade Ally agrees to act and represent its business as an independent contractor and at no time will Trade Ally or any of the Trade Ally's employees represent its business as an employee, agent, partner or representative of Montana-Dakota. Trade Ally has no right or power to bind Montana-Dakota or act on its behalf when dealing with customers or third parties. Trade Ally and Montana-Dakota shall not exercise any control or supervision of one another, nor be responsible for each other in the performance of any service.
- 7. Trade Ally understands that Montana-Dakota is not endorsing Trade Ally's business, or warranting or endorsing any equipment that may be sold by the Trade Ally. Under no circumstances shall Montana-Dakota be liable to the Trade Ally for any direct or indirect losses, costs or damages arising from or related to any equipment or installation under the program.
- 8. Trade Ally may discontinue participating as a Trade Ally by notifying Montana-Dakota in writing of that decision. Montana-Dakota may end Trade Ally's participation at any time, at their sole discretion, by notifying Trade Ally in writing of that decision.
